

# 2024 ANNUAL REPORT TO VILLAGE OF NEILBURG CONSUMERS

For the reporting period of January 1, 2024 to December 31, 2024 we met all regulations governing the quality of the water both as it leaves the treatment plant and at the point of use as measured throughout the distribution system.

## TREATED WATER QUALITY

We are required, on a daily basis, to ensure our water leaving the treatment plant contains sufficient levels of disinfectant. This is measured as the Free Chlorine residual and the Total Chlorine residual. For each of these parameters 365 tests were required and 365 tests were performed with all results meeting or exceeding our required disinfectant levels.

We are also required to perform daily turbidity readings of the water leaving the plant and also of the water coming out of each filter. Turbidity is a measure of the degree to which the water loses its transparency due to the presence of suspended particulates. We are required to maintain turbidities of less than 1.0 NTU at each of these three test points. For each point, 365 tests were required and 365 tests were performed.

#### **DISTRIBUTED WATER QUALITY**

Every two weeks we are required to sample the water coming out of our distribution system. Each time, two samples are taken. One for testing for disinfectant levels and the other is sent away for bacteriological testing.

During this period 24 samples were required and 27 samples were taken. All 27 samples met or exceeded the required disinfectant levels and of the 27 samples sent away, none of them tested positive for bacteria.

On October 22, 2024 the Village of Neilburg was placed on a Precautionary Drinking Water Advisory (PDWA) by the Water Security Agency due to an unexpected 4-hour power failure at the Water Treatment Plant. The Precautionary Drinking Water Advisory was rescinded by the Water Security Agency on October 31, 2024 after the required two (2) consecutive sets of three (3) bacteriological samples from the distribution system was returned with acceptable results.

## GENERAL CHEMICAL/ HEALTH AND TOXICITY

Every second year we are required to submit samples of our treated water for comprehensive testing at an accredited lab. This testing monitors levels of substances commonly found in water that can affect our health if present at concentrations above the levels considered to be safe. The testing also characterizes the compounds in the water that, although typically harmless, can reduce its aesthetic value. These compounds include hardness as well as ones that can give water an unpleasant taste, smell or color. This testing was done in October 2023.

Although our water contains more minerals than we would like, as far as health concerns go, we have no harmful substances that exceed the regulated maximum allowable levels.
