The Council of the Village of Neilburg in the Province of Saskatchewan enacts as follows:-

- 1] Bylaw No. 2 to license, regulate and govern hawkers and peddlars passed on the 27th day of January 1947 and approved February 22, 1947, is hereby repealed.
- 2] Bylaw No. 4 to compel the removal of dirt, stones, filth, dust or rubbish off the streets, lanes or other public places within the Village passed on the 27th day of January 1947 and approved February 22, 1947, is hereby repealed.
- 3] Bylaw No. 5 to prevent the leading, riding or driving of horses or cattle on sidewalks passed on the 27th day of January 1947 and approved February 22, 1947, is hereby repealed.
- 4] Bylaw No. 7 respecting buildings passed on the 11th day of November 1948 and approved December 1, 1948, is hereby repealed.
- 5] Bylaw No. 9B to provide for medical care for the residents of the municipality passed on the 8th day of November 1949 and approved October 19, 1949, is hereby repealed.
- 6] Bylaw No. 12 to provide for licensing of owners of cows, the milk or cream from which is offered for sale within the Village, and of persons operating dairies or depots within the Village at which milk or cream is treated, bottled or otherwise handled in bulk passed the 27th day of January 1947 and approved February 20, 1947 and February 26, 1947, is hereby repealed.
- 7] Bylaw No. 13 to license and regulate the use of drays passed the 14th day of June 1949 and approved June 20, 1949, is hereby repealed.
- 8] Bylaw No. 15 to authorize the signing of an exclusive contract with David Maxwell Campbell to supply light and power to the Village passed the 13th day of November 1947, is hereby repealed.
- 9] Bylaw No. 16 respecting the prevention and extinguishment of fires passed the 8th day of May 1947 and approved June 19, 1947, is hereby repealed.
- 10] Bylaw No. 17 to appoint a Village constable, fix his remuneration and prescribe his duties passed the 17th day of June 1947, is hereby repealed.

- 14] Bylaw No. 21 respecting social aid passed the 29th day of May 1959, is hereby repealed.
- 15] Bylaw No. 22 respecting assessments on land not subdivided into lots and located within the Village of Neilburg which are exclusively used for farming purposes passed the 4th day of December 1959, is hereby repealed.
- 16] Bylaw No. 24 for borrowing \$26,000.00 for the purpose of paying the cost of installing a sewage system passed the 5th day of October 1962 and approved January 24, 1963, is hereby repealed.
- 17] Bylaw No. 24A provides for financing the cost of installing a sewerage system in the Village (consisting of sewage pumping stations, force main and a two-cell sewage lagoon) by way of debentures to the extent of Twenty-Six Thousand Dollars (\$26,000.00) passed the 21st day of May 1963, is hereby repealed.
- 18] Bylaw No. 25 to provide for the time and place of voting on a certain bylaw, number 24 of the said Village and to appoint a returning officer for taking votes of the burgesses passed the 31st day of August 1962, is hereby repealed.
- 19] Bylaw No. 26 to authorize the construction of sewer mains on certain streets of the Village as a local improvement passed the 29th day of April 1963, is hereby repealed.


