A BYLAW TO PROVIDE FOR RESCUE SERVICES

The Council for the Village of Neilburg in the Province of Saskatchewan enacts as follows:

1. The Village of Neilburg is hereby authorized to enter into an agreement in reference to rescue services, attached hereto and forming part of this bylaw identified as Exhibit "A" for the purpose stated in the agreement.
2. The Mayor and Administrator of the Village of Neilburg is hereby authorized to sign and execute the attached agreement identified as Exhibit "A".

Memorandum of Agreement made this 26th day of August, 2016.

Between: Rural Municipality of Hillsdale No. 440

– and –

Village of Neilburg

– and –

R.M. Manitou Lake Fire & Rescue Co-operative Ltd.

The Parties agree together as follows:

1. The parties to this agreement agree that the R. M. Manitou Lake Fire & Rescue Co-operative Ltd. will provide rescue services within the boundaries of the Village of Neilburg and that portion Rural Municipality of Hillsdale No. 440 described as follows:
 - Township 43 Range 24 – Sections 1 to 36 inclusive
 - Township 44 Range 24 – Sections 1 to 36 inclusive
 - Township 45 Range 24 – Sections 1 to 11, 14 to 23, and 26 to 35
 - Township 43 Range 25 – Sections 1 to 36 inclusive
 - Township 44 Range 25 – Sections 1 to 36 inclusive
 - Township 45 Range 25 – Sections 1 to 36 inclusive
 - Township 43 Range 26 – Sections 1, 12, 13, 14
 - Township 44 Range 26 – Sections 1, 12
2. The parties to this agreement agree that the Village of Neilburg and the Rural Municipality of Hillsdale No. 440 pay the following sums for rescue services as outlined above, namely:
 - a) **Annual Fee** – An annual fee of 0.30 mill on the taxable assessment of lands listed in the agreement within the Rural Municipality of Hillsdale No. 440 and the Village of Neilburg. The annual fee shall be re-examined in a municipal revaluation year.
 - b) **Payment** - Payment shall be made by September 1 of each year.
 - c) **Annual Meeting** – The annual meeting shall be held by March 1st of the year.
 - d) **Rescue Services** – Schedule "A" to this agreement
3. The Rural Municipality of Hillsdale No. 440 and the Village of Neilburg shall each appoint a voting member to the board of directors of the R.M. Manitou Lake Fire & Rescue Co-operative Ltd.
4. It is understood and agreed that this agreement shall be in effect on a continuing basis commencing on execution of all parties, and may be terminated by any party by giving sixty (60) days notice in writing. It is further agreed that a review and update will be conducted by the parties to this agreement at the end of every fifth year.

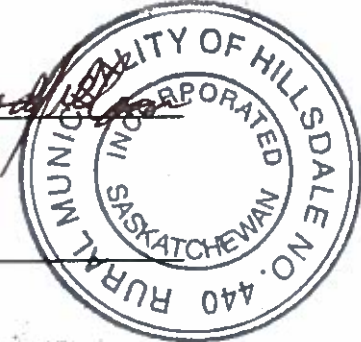
